## Footnotes | View Glossary Of Terms

AWESOME TRAIN rated just off of the early pace and tracked from the inside into the first turn, was well placed along the backstretch while a bit off of the rail, angled three wide nearing the quarter marker, responded to upper stretch and closed determinedly in the late stages, surged in deep stretch and got up for the win in the final strides. SWASHBUCKLE was prominent into the first turn, stalked the decent early pace then pressed CAMP EVANS along the backstretch, dueled outside of that rival into the far turn, gamely battled for the lead to upper stretch, was bested by the oncoming winner in the final strides and held safely in the end for second. CAMP EVANS broke well and assumed early command, set a decent pace while prompted up the backstretch, dueled SWASHBUCKLE into the far turn and held the lead to upper stretch, was overtaken into the final sixteenth and was clear in the end for third. THE THOR (CHI) settled off of the early pace, raced widest to the half-mile point, chased three then two wide into the far turn and did not offer a late response. FIVEEYESONSKYSTARS close up in the early stages, tracked the decent pace three wide up the backstretch, chased four wide to the quarter marker, could not keep pace to upper stretch and weakened. GIVE ME LIBERTY off a bit slow leaving the start, was unhurried to the backstretch, advanced three wide into the far turn, flattened out in the stretch drive and did not threaten late. PUCKERED allowed to settle while never far back, saved ground into the backstretch run, lacked a response to the far turn and tired in the stretch.
