RACETOTHEFINISH, bumped at the break, took a slim lead soon after, secured the inside and set a pressured pace under rating, battled on near even terms with A REAL HERO leaving the five sixteenths, responded to firm asking and shook clear leaving the three sixteenths, increased her advantage past the furlong grounds and was kept alert to the final yards. A REAL HERO saved ground off the embattled leaders, was under a ride mid turn, worked outward for the final furlong, finished up willingly and nabbed the place in the final yards. LOST SUNSET got into a battle outside the winner soon after the start, stayed latched on under pressure around the turn, failed to match strides leaving the three sixteenths, faded through the final seventy yards and lost the place late. RUNNERS HEAT broke outward bumping the winner, corrected and stalked outside A REAL HERO, came three wide for the drive and failed to kick on. JERSEY GOLD, a bit fractious in the gate, dropped off the pace after a furlong, angled out in the lane and failed to generate a response.
