POLSKA SUE sped to the early lead and took outer pressure into the backstretch, was rated back off WW BEST OF TIMES nearing the five eighths then stayed on to stalk, picked things back up saving ground into the stretch, eased out with a furlong to go, came back determinedly under a solid hand ride, forged back to command in deep stretch and edged clear at the wire. WW BEST OF TIMES vied outside the winner around the first turn, pulled her way clear leaving the five eighths, drop in and widened leaving the three eighths, remained clear under a drive past the furlong grounds, kept on with good effort but was unable to deny the winner's outer resurgence. TRINITYTHREEINONE broke outward, corrected and settled well off the pace while saving ground, cut the corner into the lane, eased out, split rivals leaving the furlong grounds and finished up with good energy. CATNIP HILL rated inside early on, angled out around the final turn, shifted out four wide past the three sixteenths but failed to kick on. SHE'S FIERCE angled in around the first turn, settled in the clear near the five eighths, came under a ride leaving the far turn, chased into the stretch then faded in the final furlong. HELEN OF C'VILLE, four wide early, was not a factor. GLAMORA (IRE) stalked off the inside and outside a rival nearing the half, was under pressure pursuing the leader leaving the three eighths, lacked a response into the stretch and weakened. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
