## Footnotes | View Glossary Of Terms

RED RIZZLER saved ground chasing the leaders past the three eighths, eased out with progress near mid stretch, moved up to engage from the outside soon after, wrested command near the sixteenth pole and edged away under a drive. WHATDOYOUTHINKMARK accelerated to the inside of a rival to take command after a furlong, spurted clear into the turn, widened a bit under some coaxing past the five sixteenths, remained clear under a drive heading to the furlong grounds, dug in when joined by the winner then ceded grudgingly in the final fifty yards. CODE NAME bore out at the break, corrected and edged up three wide, chased between foes into the stretch then went evenly through the final furlong. NAGY AND DA BEARS broke a step slow then steadied when reacting to CODE NAME, raced well back leaving the far turn, saved ground in upper stretch and finished with effort. RAVIN'S TOWN, four to five wide, edged up some near the three sixteenths, switched over to the left lead leaving mid stretch and faded. SEVERANCE, off the pace while saving ground early, failed to menace. DINOS DIXIE sped to the early lead, was overtaken by an inner charging foe heading towards the half, stayed on to chase around the turn, was under a hustling ride three wide into the lane, lacked a punch past the three sixteenths and tired. An objection by the rider of NAGY AND DA BEARS against CODE NAME alleging interference leaving the gate was not allowed.
