DESSERT FIRST got caught four-wide on the clubhouse turn, continued to race wide down the backstretch, launched a bid from the three-furlong pole, took aim on CAME UP ROSES in upper stretch, put in a grinding finish under steady handling and urging, and got up in the last jump. LUNARCHY made the front, set a slow pace to the far turn, lost the lead to CAME UP ROSES midway through the turn, but kept to task, and came back on that rival in deep stretch, gained the lead just yards from the finish, but got nailed by the winner at the line. CAME UP ROSES was content to stalk the pacesetter to the far turn, took command after passing the five-sixteenths marker, held a clear lead into the stretch, shortened strides in the last furlong, and was overtaken near the finish. SHE BE SHEEHAN settled mid-pack inside, finished up well, but was not quite good enough. JULIAISON settled in cover in the middle of the pack through the early stages, then was mildly gaining late. JOYZELLA tracked in the forward half of the field through the early stages, was under a ride to keep up on the turn, then went one-paced through the stretch. LILY'S CREED settled inside near the early stages, steadied near the seven-sixteenths marker, dropped to last, and was unable to recover. LUCY'S LOOKIN LEFT was allowed to settle from the break, raced near the rear, then lacked a rally. SILKY WARRIOR (IRE) settled at the back and never threatened.
