CLASSIC KITTEN saved ground, rallied at the quarter pole and was in time under steady handling. REDHOTJUSTICE saved ground, rallied in early stretch and was outfinished. GONNAGETCHAGETCHA pressed the pace in the three path, bid at the three-quarters pole, dueled and was outfinished. MIDNIGHT CAPER was unrushed early and rallied through the stretch. PASSIONFORJUSTICE was clear early in the two path, was challenged on the outside near the three-quarters pole, dueled thereafter and couldn't hold off the closers. SARAH'S SMILES stalked the pace in the three path and lacked a late bid. SHE'S A WHIRLWIND raced in the three path and was steadied near the sixteenth pole. NO TRUST saved ground to no avail. J'S NAUGHTY KITTEN was impeded at the start and raced evenly. ACE OF CATS raced in the four path and faded in the stretch.
