EINSTEIN'S GHOST was bumped hard at the start, dueled inside, bid in the two path on the far turn, tried to bolt near the quarter pole but recovered, dueled through the stretch and drew off under a mild drive. QUALITY DANCER stumbled badly at the start, raced unrushed early, rallied inside near the half-mile pole, dueled inside in the stretch but was no match for the winner. CRAB CRUNCH veered in at the start, raced inside, bid on the far turn, moved to the four path at the quarter pole, was checked when the winner came out, then gave way down the stretch. GIMMEL was off awkwardly, raced in the six path and improved position late. STORM BACK was bumped at the start and raced evenly in the three path. AMIGOMEISTER stalked the pace in the three path and gave way on the far turn. MY MILEY'S VOW was through early. PADDY'S DREAM dueled early, stalked the pace in the three path and gave way in the stretch. THE STEWARDS TOOK NO ACTION AFTER AN INQUIRY BY THE RIDER OF CRAB CRUNCH AGAINST THE WINNER ALLEGING INTERFERENCE NEAR THE QUARTER POLE AND AN INQUIRY INTO THE START AND THE RUN AROUND BOTH TURNS.
