JOLLY JUSTICE was unrushed in the early going, bid in the three path between rivals near the quarter pole and was in time under steady urging. MOLLY'S POTION stalked the pace in the three path, bid near the half-mile pole and was outfinished. SOLRUN saved ground and bid late outside. SHESMYHUCKLEBERRY was clear early in the two path, was bested, then fought back and was caught. CHARMING JAZEL raced well back and rallied late between rivals. ENCHANTED MELODY stalked the pace in the four path, bid at the eighth pole and couldn't close late. AMAZINGNESS stalked the pace between rivals and faded on the far turn. HERE KITTY KITTY was not a factor.
