CAUSE A RUCKUS stalked the pace inside, bid in the three path near the half-mile pole and drew off in the stretch under a mild drive. FIREWATER JAKE led between foes, dueled inside and then couldn't hold off the winner. GUCCI MAN pressed the pace inside and gained the show late. VACCINATOR raced in the four path and bid belatedly. RACE DAY REBAL vied in the three path, dueled outside of a foe and gave way in the stretch. CHEESESTEAK stalked the pace in the four path and had no late bid. ACE ON THE TURN was unrushed early, moved to the six path near the three-eighths pole, was bumped at the quarter pole and had no late bid. TAPAKENA saved ground to no avail. DEVILS GOTTA GO stalked the early pace between rivals and gave way near the five-eighths pole.
