JESS SINFUL back-end bumped early. SWEET DREAMS broke in, forced in. CYBER FLASH checked 1/16, angled in. JOYFUL DYNASTY shut off early, angled in. CANDY SPICE forced in shut off, in hand. AFTER AN OBJECTION BY THE TRAINER OF #9 DELREYS ROLLIN BAYOU AND AN RIDER'S OBJECTION BY THE RIDER OF #8 CYBER FLASH AGAINST THE RIDER OF #7 CANDY JAR FOR INTERFERENCE NEAR THE SIXTEENTH POLE, #7 CANDY JAR WAS DISQUALIFIED FROM SECOND (2ND) AND PLACED EIGHTH (8TH).
