EREBUS chased between, dueled stretch, best. LUCK'S ROYAL FLUSH dueled 2wide, dueled stretch, gamely. PAPA TIGER very fractious, stalked inside, steadied 1/4, best rest. GROSS PROFIT far back, belatedly inside. EXHALTING dueled inside, gave way 1/8. NEWPARK (IRE) chased inside, lugged out turn. SHAKE N FRIES chased 3-4wide, tired upper stretch.
