GUNNER rallied clear on the turn digging in down the lane weakening late under outside pressure. CAESAREA hustled along chased five wide into upper stretch finishing evenly. SPRINGS pursued close up through the turn then weakened in upper stretch. NATIONAL PUNCHLINE slow early played no factor. RAVEN'S HONOR was never involved. BRIARCLIFF chased through the turn tiring in upper stretch. SIETE SIETE SIETE led with early speed giving way on the turn.
