DREAM KNIGHT hustled early, tracked two-wide behind AMIGO'S AFFAIR to the stretch, then made a bid up the rail under strong handling and urging, outgamed that stubborn foe in deep stretch, and edged clear in the final yards. AMIGO'S AFFAIR broke well, established command early, took a short lead into the stretch, finished willingly under steady handling and urging, but was outkicked in the final yards by the winner. BROADWAY JONES raced five-wide in the second flight, was the widest of a five-horse fan at the top of the stretch, and finished with good interest but could not get to the top pair. GILLIGAN veered out at the start into the path of BAD BOY BOOGIE, then moved up to chase AMIGO'S AFFAIR late down the backstretch and through the turn, was with a chance at the top of the stretch, then was being forced in by BROADWAY JONES, had to alter course near the furlong pole, lost some momentum, and was unable to threaten late. AGNELLO'S DREAM ducked in at the start, then moved up to race close to the early leaders down the backstretch, kept to the inside through the turn and finished evenly while never a serious threat. PRACTICAL MAN broke well, then was having to be coaxed along to maintain forward position, dropped to last before the turn, then was kept to task and passed a couple of stragglers in the stretch. MAXWELL ESQUIRE dropped to last position after the start, then advanced four-wide through the turn, but was unable to summon a rally in the stretch. BAD BOY BOOGIE was off slowly and awkwardly, then took up as two horses converged in front, trailed to the turn, then launched a bid approaching the half, but was unable to sustain, and had nothing left for the stretch run. THE JOCKEY ON #5 GILLIGAN LODGED A CLAIM OF FOUL AGAINST #7 BROADWAY JONES ALLEGING INTERFERENCE IN MID-STRETCH. AFTER A REVIEW, THE OBJECTION WAS DISALLOWED AND THE ORIGINAL RESULTS MADE OFFICIAL.
