WARRIOR'S DEFENSE cleared early, set the pace in the two path, was scrubbed along around the final turn, kept on under left handed asking while remaining on her left lead through the lane and proved resolute to the wire. CASA JUANITA prompted the pace three wide outside the winner, gave game chase from the head of the lane but was kept at bay. UP N RUNNIN broke a step slow, rated off foes into the backstretch, angled to the inner rail approaching the stretch, chased on to the inside of a rival through the final furlong and gained the show. GENIEINABRIDLE broke slowly, lost ground three wide around both turns and came up empty. BREEZETHRUTIME, away a bit awkwardly, saved ground, raced in range to the half, lacked a response leaving the far turn and faltered.
