PRACTICALITY edged up along the inside early on and stalked, dropped back a bit under coaxing three furlongs out, came back on and slipped through to the inside of rivals to bid past the three sixteenths, poked a head in front leaving the furlong grounds, went clear under a drive with a sixteenth remaining then was fully extended to prevail. BURNING EMBERS , three to four wide, took closer order past the quarter pole, angled further out for the final furlong and closed gamely. WARRIOR'S TREASURE drifted out at the break and was away towards the back, corrected and made a quick four wide advance to contention, tracked around the turn, bid four wide past the three sixteenths then was steadied when bothered by the loose horse, regrouped and kept on with effort. EARLY FROST , reluctant to load, was taken to rate while off the inside, swung six wide for the drive and finished with good energy. ILLUSION OF HOPE , off the pace while saving ground, worked outward in the drive and finished with interest. HAPPYBIRTHDAYCOREY , fractious in the gate, raced off the pace and three to four wide, was floated out by the loose horse near the three eighths, continued wide past the quarter pole, dropped inside for the final furlong and kept on trying. BETCHA BOOTS BABE sped clear early, set the pace towards the inside, entered the lane about three wide, was joined from both sides in mid stretch and weakened. LA LIMA , inside, faded around the turn. WARRIOR BERNICE chased the early pace between rivals, was shuffled back leaving the half, steadied when impeded by the loose horse leaving the far turn then faltered. ARUMA reared up at the start and lost her rider.

There was a stewards' inquiry into the start of ARUMA. No action was deemed necessary.
