CITY TRIPPER rated in mid-pack down the backside, swung five wide rallying turning for home, battled LOUISIANIMAL in mid-stretch, edged away nearing the sixteenth pole and dug-in to hold the runner-up safe at the wire. THE SINNER IS YOU unhurried early to be near the back of the field, saved ground through the turn, angled well out to the clear in upper stretch and closed well belatedly to be gaining at the wire. LOUISIANIMAL stalked the pace from three wide to the top of the lane, rallied to the lead in upper stretch to battle the winner and was outfinished late by the top pair. CAMINO DE SANTIAGO reserved off the pace while wide down the backside, rallied turning for home to close the gap in mid-stretch and finished evenly unable to sustain the bid. YARDMAN passed tiring rivals in the lane without impact. CALYPSO CHARLIE tracked the leaders from the fence to no avail lacking a closing kick. STRIDER'S SLIDER set a pressured pace to the head of the lane and tired. STRAIGHTOUTADUTTON pressed the pace for a half and gave way at the head of the lane.
