GRAND MORNING set the pace under pressure while well rated to the far turn, repelled the presser on the bend and responded well to draw off in the alne unchallenged. RIVER OF TIME stalked the pace from four wide down the backside, made a steady rally on the final turn to close the gap, failed to match strides with the winnerin upper stretch and ran-on willingly to hold the place. MOHTAFIL reserved off the pace for the first half mile, rallied on the turn circling six wide to contention at the top of the lane and could not get passed the top pair. CHILL BOSS tracked the pace from the inside saving ground, tipped three wide to loom in mid-stretch and flattened out in the final furlong. THIRD CITY unhurried to race near the rear of the field, rallied mildly on the far turn and finished evenly unable to sustain the bid. KUNOOZ failed to menace. HINENI was not a threat. HERONEANDONLY pressed the pace for five-eighths, rallied to threaten on the turn, failed to get passed the winner and gave way turning for home. CAPTURETHELAUGHTER chased the leaders for a half mile and faded from contention.
