ALLEN'S AGENDA hustled up out of the gate and cleared the early lead, held firm around the turn, came under a ride two wide entering the upper stretch, had plenty left in reserve, widened advantage and kept to task under steady encouragement. CREEK FRONT raced just off the early leader, tracked rival around the turn, was ridden along two wide into the lane and finisihed clear over the rest. TIMEFORWHAT raced in contention two wide in early stages, saved ground around the turn and ran on for a share. POST HASTE raced in the back along the outside, came three wide into the lane and failed to threaten. CARME showed response in opening stages then steadily weakened.
