## Footnotes | View Glossary Of Terms

BLISTER BUG vied three wide for the early lead, angled in a path entering the turn and tracked the leader into the upper stretch, launched a three wide bid at the head of the lane and drew clear. DIAMOND OF EKATI vied for the early lead then shook free and held clear around the turn, remained the clear leader a furlong out then got overtaken late. LEUCADIA raced two wide off the top flight late on the backstretch, lost path entering the turn, ran on two to three wide into the upper stretch, finished with good response and just missed place. JOYFUL JOSEPHINE settled in early stages, saved ground and edged closer along the rail late on the turn, came two wide upper stretch then shifted back to the rail, crept up into close contention then yielded late. SHANIAH vied for the early lead, chased two to three wide into the stretch and evened out late. MILLIGANMIKEANDME sat just off the early pace, made a brief move four wide entering the turn, gained position then failed to sustain bid and faded in the lane. FIREBAUGH lacked speed and failed to move into contention. THE RIDER OF LEUCADIA CLAIMED FOUL AGAINST BLISTER BUG FOR INTERFERENCE AROUND THE TURN, AFTER REVIEW NO ACTION WAS TAKEN
