COMININALITTLEHOT stalked along the inside or a bit off the rail, saved ground through the far turn, eased out leaving the bend and further out at the top of the lane, challenged from outside approaching the eighth pole, put a head in front shortly after and edged clear from rivals on both sides late. MISSILE CRUISER settled next to the fence off the pace, drew closer in the middle stages, angled four wide around the far turn, launched a bid in upper stretch, fought three deep in the furlong grounds but got outkicked by the winner. SMILING TIZZY showed the way early on the inside, controlled the pace up the backstretch, remained unchallenged to the top of the lane, confronted by the winner in upper stretch, lost command past the eighth pole, kept on trying in deep stretch but got outfinished for second. FLEXIBLE TERMS tucked inside at the back, trailed to the stretch and passed tired rivals. DIRTY WORDS dueled briefly for the lead from inside then allowed SMILING TIZZY to take the lead, moved into the two path around the first turn, was closest in pursuit up the backstretch, chased two wide around the far turn, spun three wide into the lane and weakened in the final furlong. JUMPER CABLES sat off the pace in the two path, moved into striking distance on the backstretch, chased three to four wide on the far turn and also weakened.

SHADY APPEAL vied three deep on the backstretch, confidently handled still three wide on the turn, carried a short lead turning into the lane, inched ahead in upper stretch, put ZOMBO BOMBO away midstretch and held gamely while brushing with MONGOLIAN ALTAI late. MONGOLIAN ALTAI showed brief speed then chased the top trio up the backstretch, coaxed along two then three wide around the bend, latched onto the winner past the eighth pole, tried to wear down the winner while brushing late but got denied. ZOMBO BOMBO fought for command between rivals up the backstretch and around the turn, dueled inside SHADY APPEAL entering the lane, fought to midstretch and weakened in the final sixteenth. VALENTINES CANDY raced up close from inside then dropped back just out of range on the backstretch, chased on the inside then two wide on the turn, angled out and lacked further response. ENOUGH ALREADY trailed off the rail in the early going, took the turn three then four wide, drifted out in upper stretch and weakened. TROTSKY chased briefly then was hustled forward between rivals to challenge for the lead, vied for command inside a pair of rivals to the quarter pole, could not keep up with outer pair late on the bend and gave way down the lane.

YOGI BOY stalked along the inside into the turn, moved into the two path midway around the bend, waited behind the leaders leaving the turn, split foes to take over in upper stretch and drew clear. NEWS AT TEN (GB) stalked outside rivals, bid three deep on the turn, fought outside YOGI BOY to midstretch, was no match for that rival late but stayed on to secure second. MR. LEASURE pressed the pace from outside, took a narrow lead dueling in the two path on the turn, lost command in upper stretch and yielded to the top pair. TRAVELIN' SHOW tracked off the rail then went two wide into the turn, angled four wide around the bend, bid four deep in upper stretch but could not summon the needed late kick. BOLT SUPREMACY broke a step slow, saved ground at the back, stayed on the fence in the lane and ran into mild traffic midstretch, then weakened late. CREATIVE OM took control early and led under pressure from MR. LEASURE up the backstretch, fought inside a pair of rivals on the turn, yielded in upper stretch and retreated.

MR. DISRESPECTFUL established the front quickly moved over to the rail around the first turn, controlled the pace up the backstretch, kicked away past the five-sixteenths pole, opened up when asked right handed at the top of the lane and coasted through the last sixteenth. MALIBU ROCKS stalked in the two then three path outside a rival on the first turn, moved out on the backstretch, chased four then three wide on the second bend and bested the rest. RESEMBLANCE rated along the inside then eased off the rail around the first turn, moved out wide on the backstretch, chased five wide into the far turn then quickly moved into the four path and churned on through the lane to gain third. LOOKS RARE stalked from inside then in the two path early, was closest in pursuit to the far turn, roused on the far turn only to watch the winner kick away past the five-sixteenths pole, driven two wide into the lane and weakened.

ATITLAN reserved in the early going while angling to the inside on the first turn, pulled from the five-eighths pole to the nine-sixteenths marker and had to steady, traveled along the rail into the final turn, angled four wide around the bend, drew alongside the leader past the eighth pole and drove clear. DIVIN PROPOS (FR) tracked outside a rival early, altered out crossing over the dirt, traveled three then four deep around the clubhouse turn, drew closer four wide in the middle stages, bid three deep with three furlongs remaining, cleared and crossed over at the quarter pole, challenged by the winner past the eighth pole, yielded to that rival and stayed on to secure second. GOLD PHOENIX (IRE) settled inside off the pace, moved into range on the clubhouse turn, crept closer on the backstretch, got boxed in and had to steady around the third turn, angled to the inside in the lane and finished well while moving back out late but could not get by DIVIN PROPOS (FR) for second. EASTER (FR) broke a step slow and got shuffled back, pulled early the early stages, tugged forward between rivals on the backstretch, chased two to three wide around the final turn, followed in range to the eight pole and failed to produce a bid. JERRY'S SPIRIT dueled from outside, shook free around the bend, asked left handed in upper stretch and was ridden out to the wire. CAROL'S COMIC tracked off the rail out of range, went between rivals at the seven-sixteenths pole, got shuffled back behind STAN FROM MALIBU on the turn, angled out into the clear and finished well to best the rest. ROGUE SON raced outside a rival near the back then between rivals into the turn from the three path, angled five wide around the bend and gained third. NAVY MAN traveled along the inside off the pace, eased out to the four path around the bend and improved position. TRINIDAD raced in range up the backstretch, crept closer nearing the turn, asked three then two wide around the bend and weakened. ALWAYS ON CAY showed brief speed then stalked the top pair up the backstretch, lost ground from the fence on the turn, moved out in upper stretch and weakened. STAN FROM MALIBU dueled for command from inside, could not keep up with the winner approaching the five-sixteenths pole, chased near the fence to the lane and tired. ACE OF CLUBS lacked early speed, raced in the four path into the turn outside rivals, spun five wide into the lane and was never a factor.

RUNAMILEINMYSHOES stepped to the front and showed the way along the inside, remained clear to the top of the stretch, roused and flagged with the right hand in the lane and stayed clear under urging to the line. ETERNAL REIGN (IRE) tracked two wide, raced out of range into the far turn, drew closer between rivals around the bend, got bumped with WORD PLAY (GB) in upper stretch and finished willingly for second. WORD PLAY (GB) stalked along the rail, was closest in pursuit with a quarter mile remaining, tipped at the top of the lane, bumped with ETERNAL REIGN (IRE) shortly after and could not produce a bid. NEEDLEPOINT (IRE) got crowded between rivals shortly after the start, began to pull and steadied between rivals into the first turn, continued to pull around the bend, was ridden along two wide then along the rail on the second bend and lacked a rally. DEFIANCE brushed leaving the gate, reserved in the three path, moved inside on the backstretch, eased two then three wide around the far turn, tipped out at the top of the lane and improved position. LOVIN' ON THE RUN traveled along the inside off the pace, coaxed along the rail on the far turn, chased two wide leaving the bend,

lugged out in upper stretch and failed to respond. CORNELIA FORT settled outside a pair of rivals early, chased two wide on the far turn, moved out in the drive and failed to menace. DELUSIVELY brushed outer rival leaving the gate, lagged behind on the inside and was never a factor. VALKYRIAN (IRE) was closest in pursuit of the pacesetter to the far turn, chased two then three wide around the bend and faded. THERE WAS A STEWARDS' INQUIRY INVOLVING THE STRETCH RUN BETWEEN ETERNAL REIGN (IRE) AND WORD PLAY (GB). FOLLOWING A REVIEW, THE STEWARDS RULED THAT BOTH HORSES CONTRIBUTED TO THE INCIDENT AND THEREFORE NO ACTION WOULD BE TAKEN.
