IT'SGOODTOBESEEN for the lead four wide, responded under right handed urging to make the lead before the furlong marker then drew off under strong handling. PROSECUTOR dueled for the lead two wide until deep stretch and finished a game second. SUSIE'S KID raced outside and improved position through the stretch. GONE IN A FLASH pressed the pace three wide into the stretch then faded. INTO GOLD battled for the lead along the inside until mid stretch then was used up. SPEEDY MOBILE failed to menace.
