G T THREE FIFTY pressed the pace along the inside into the turn, dropped back and shifted two wide before the quarter pole, made the lead entering the stretch then drew off under right then left handed urging. LUNCHATTHELIZARD set a pressured pace two wide to the top of the stretch, altered course to the three path near mid stretch and was no match for the winner. OVERLOAD allowed to settle, had a mild late rallied in the four path. SERENDIPITOUS failed to menace. SHOW SLIDING HOME hopped at the start and was no threat. DANES HEART stalked the early pace three wide and was through after a half. ATTACK ANGLE was no factor. THE STEWARDS POSTED THE INQUIRY SIGN BUT TOOK NO ACTION.
