CANDLELIGHT HOURS never far back, advanced steadily three wide down the backstretch, made the lead midway on the far turn then widened the balance of the trip to win as much the best under confident handling. GENEROUS LOVER away alertly, set the pace for six and one half furlongs then was no match for the winner while clearly second best. HERE'S THE SPIDER stalked the pace inside rivals and went evenly. LIONISTIC raced in the six path into the clubhouse turn, chased the pace in the three path into the far turn, drifted to the five path at the top of the stretch then weakened. KETTLE KISS was never close.
